A Motion Setting A Public Hearing on the Proposed Millennial Moments
Joint Economic Development District Agreement Between
The City of Canfield and Canfield Township.

WHEREAS, in accordance with the Ohio law, the City of Canfield ("City"), and Canfield Township (the "Township") desire to create the Millennial Moments Joint Economic Development District (the "District") for the purpose of facilitating economic development, creating jobs and employment opportunities, and improving the economic welfare of the people of the City, the Township, and County, and the State of Ohio; and

WHEREAS, the City and the Township, desire to enter into a Joint Economic Development District Agreement (the "Agreement"); and

WHEREAS, the Joint Economic Development District Statutes (Ohio Revised Code Section 715.70 et seq.) and, in particular Ohio Revised Code §715.70, require the legislative authorities of each of the contracting parties to hold a public hearing concerning the Agreement and the District, prior to enacting legislation approving the Agreement; and

WHEREAS, Council desires to establish the date of the City's public hearing and authorize the Clerk of Council to publish notice of the public hearing.
