That a new Canfield Codified Ordinance Section 1159.01 is hereby adopted as follows: "1159.01 Architectural Character Requirements. The main building of an institutional or commercial use shall have architectural character consistent with its public nature. It shall be easily distinguished from residential buildings. The architecture of a commercial building may not act as a recognizable logo for a national corporation or franchise. The building architecture is deemed to be a "logo" when the specific business occupying the proposed building could still be easily identified if all the allowable signs were to be removed." That current Codified Ordinance sections 1159.01 and 1159.02 are hereby re-numbered as sections1159.02 and 1159.03 respectively. Section 3.
