AN ORDINANCE AUTHORIZING CHANGE ORDER NUMBER 1 & FINAL FOR THE CHAPEL LANE STORM SEWER IMPROVEMENT PROJECT
WHEREAS, the Council of the City of Canfield authorized the Manager to enter into a contract with Utility Contracting Inc. on August 12, 2015 in an amount not to exceed \$33,060.00 based on a public bid; and
WHEREAS, the Engineer recommends a Change Order #1 (final quantity adjustment) pursuant to provisions of the contract; and
WHEREAS, Council desires to authorize Change Order #1 (add on of all items completed to date and a deduct of all items no longer required, resulting in a net contract decrease of six thousand four hundred forty-one dollars and $00/100$ (\$6,441.00)
