A MOTION AUTHORIZING THE CITY MANAGER OF THE CITY OF CANFIELD TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH CANFIELD TOWNSHIP REGARDING AN ANNEXATION AGREEMENT AND THE CREATION OF A JOINT ECONOMIC DEVELOPMENT DISTRICT.

WHEREAS, the City of Canfield and Canfield Township have discussed certain matters and issues related to the annexation of certain property currently located in Canfield, Township, and

WHEREAS, City Council desires to enter into a Memorandum of Understanding ("MOU") with Canfield Township with regard to the annexation of certain property and creation of a Joint Economic Development District ("JEDD") regarding certain property currently located in Canfield Township, and

NOW, THEREFORE, BE IT MOVED BY THE COUNCIL OF THE CITY OF CANFIELD, STATE OF OHIO:

Section 1: That the Council of the City of Canfield hereby authorizes the City Manager to enter into the attached MOU between the City of Canfield and Canfield Township regarding the annexation of certain property currently located in the Canfield Township and the creation of a JEDD.
