Second and third reading of Ordinances and Resolutions

161101-62 Null	Being an ordinance amending sections 187.03, 187.04, 187.05 and 187.10 or Chapter 187 of title nine of the codified ordinances of the City of Salem regarding the Economic Growth Initiative Program.

Introduction of Ordinances and Resolutions

170307-12 Whitehill	Being an ordinance authorizing the Director of Public Service and Safety to advertise for bids and enter into contract for the sale of one used 1997 one ton Chevy dump truck and one used 2000 Ford F250 super duty pickup truck and declaring an emergency.
170307-13 Whitehill	Being an ordinance authorizing the Director of Public Service and Safety to advertise for bids and enter into contract for the sale of two used 35 foot extension ladders.
170307-14 Goll	Being an ordinance providing for the issuance and sale of not to exceed \$3,000,000 aggregate principal amount of bonds of the City of Salem, to pay costs of constructing and installing improvements comprising the Snyder Road Sanitary Sewer improvement project and other wastewater system improvements in the City, including all necessary appurtenances thereto, and declaring an emergency.
170307-15 Goll	Being an ordinance to provide for the issuance and sale of not to exceed \$1,300,000 of notes of the City of Salem in anticipation of the issuance of bonds for the purpose of constructing, reconstructing and installing waterline improvements, including all necessary appurtenances, thereto and declaring an emergency.
170307-16 Paparodis	Being a resolution requesting the Columbiana County Auditor to certify certain tax valuation information in anticipation of levying a tax in excess of the ten-mill limitation.
170307-17 Paparodis	Being a resolution requesting the Mahoning County Auditor to certify certain tax valuation information in anticipation of levying a tax in excess of the ten-mill limitation.
170307-18 Whitehill	Being an ordinance directing the Columbiana County, Ohio Board of Elections to place upon the ballot at the general election on Tuesday, November 7, 2017 the question of whether a commission shall be chosen to frame a charter for the purpose of installing a charter form of government for the City of Salem and to place upon the ballot a slate of candidates who are electors from the City of Salem from which 15 shall be elected as the members of the Charter Commission.
